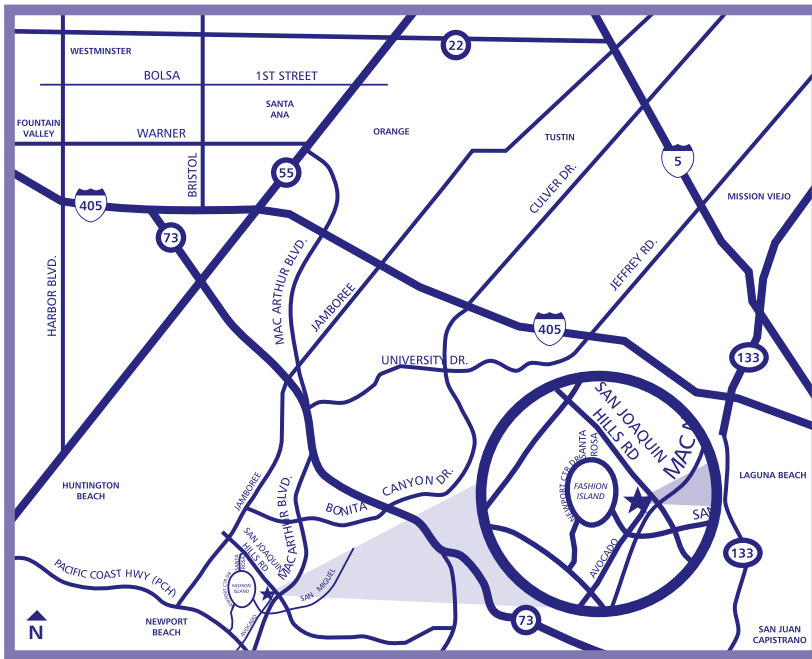

Patient Preparation For Diagnostic Procedures:

Procedure	Preparation
IVP Intravenous Pyelogram BE Barium Enema	Please follow the LoSo Prep - 24 Hour preparation instructions. Patients with COLITIS, BOWEL OBSTRUCTION or RENAL INSUFFICIENCY: Please call your ordering physician for prep instructions.
UGI Upper Gastrointestinal Series (Also Esophagram & Small Bowel Series)	Nothing to Eat or Drink for 8 hours prior to exam.
CT Computed Tomography	CT with contrast: Nothing to Eat or Drink for 4 hours prior to exam. Patients with Kidney problems, please contact our office. CT non-contrast: No preparation required. <i>If your exam requires contrast, DO NOT eat or drink anything for 4 hours prior to your exam. Please notify scheduler if you are taking medication for diabetes or have a known allergy to iodine.</i>
Mammogram or Breast Imaging	Plan to bring your prior mammography films if they were not taken at NDC. No powder, perfumes, lotions or deodorants between your neck and waist the day of the exam.
Pelvic Ultrasound	Female – Finish 32 oz of clear liquid one hour before your exam time. Male – Finish 24 oz of clear liquid one hour before your exam time. DO NOT EMPTY YOUR BLADDER
Abdominal Ultrasound	Nothing to Eat or Drink for 8 hours prior to exam.
MRI Magnetic Resonance Imaging	No preparation necessary. PATIENTS WITH PACEMAKERS CANNOT HAVE MRI STUDIES <i>Please notify scheduler if any of the following pertains to you: Cardiac Pacemaker, Aneurysm Clips, Cochlear implants, you are an Occupational Metal Worker or may be Claustrophobic.</i>
PET/CT Positron Emission Tomography/ Computed Tomography	If possible, drink plenty of fluids beginning 24 hours before your examination. Nothing to Eat or Drink for 6 hours prior to exam. <u>You may take medications with a small amount of water if necessary except diabetic medication glucophage (metformin).</u> This exam is 2 hours in length. Dress warmly and minimize wearing metal.
